Gift Aid Declaration

Using Gift Aid means that for every pound you give, the Trust gets an extra 28p from the Inland Revenue, helping your donation to go further.

This means that £100 can be turned into £128, just so long as donations are made through Gift Aid, Imagine what a difference that could make, and it doesn't cost you a thing.

If you are a higher rate Tax Payer (40%) you also can claim additional tax relief of 18% in your annual tax return.

Notes:

You must pay an amount of income tax and/or capital gains tax at least equal to the tax that the charity reclaims on your donations in the tax year (currently 28p for each £1 you give).

If in the future your circumstances change and you no longer pay tax on your income and capital gains equal to the tax that the charity reclaims, you can cancel your declaration.

If you pay tax at the higher rate you can claim further tax relief in your Self- Assessment tax return.
